- \*Kim Williams(Mayor)- Will reach out to Tripp to verify closing of old KFC building; appreciates everyone's participation in meeting.
- \*Carl Culpepper. III- agreed that two employees of Streets & Roads need a raise; they have been a blessing & vital party of the city; there will need to an additional person by next year, if not sooner, so that infrastructure won't suffer.
