Fire Department monthly report; 3<sup>rd</sup> highest number of calls in the county(report will be available with approved minutes at www.newellentonsc) Asked Coach David Alexander(Youth Sports Director) what improvements he sees that council can do; Coach David responded with needing more volunteers.

\*lason Morgan-Asked Coach David Alexander (Youth Sports Director) for a list of things that will be needed for next year so money can be found for next year.

\*Kim Williams(Mayor)-Asked residents to call City Hall if they see lights out around the city; Resource officer will be in Greendale in February. Two graduates from police academy; wanted team that worked well together and solved murder quickly in the city; almost fully staffed. Streets & Roads person lost; good team; not taking applications at this time since James Crawford is on staff and working well. The shopping center has a new owner and property manager that are working hard to clean-up area. Trailer park behind post office is zoned Highway Commercial and looking to put property up for sale. Golf course development isn't occurring at this time; issues with environmental study; Kenny will be working on changing zoning back to R-15. 1st reading will be next month. Land is being cleared at The Pines for townhomes and Phase 6. Looking into other options for health care facility for the city. Erika Ramsey has stepped down from Planning Commission and there will need to be a replacement.

\*Elvira Johnson-Holley-Anticipates a lot of growth for the city.
